ORDINANCE LIMITING THE PARKING OF MOTOR VEHICLES IN DRESBACH TOWNSHIP PARK/BOAT LANDING, PROVIDING FOR THE ISSUANCE OF PARKING PERMITS FOR DRESBACH TOWNSHIP BOAT LANDING, AND PROVIDING PENALTIES FOR VIOLATION THEREOF ORDINANCE NUMBER 2

STATE OF MINNESOTA DRESBACH TOWNSHIP WINONA COUNTY

The Board of Supervisors of the Township of Dresbach hereby ordains that Dresbach Ordinance Number 2 is hereby deleted in its entirety and replaced with the following:

<u>Section 1 – Restricted parking.</u> No motor vehicle shall be parked in Dresbach Township Boat Landing without a valid written permit issued by the Dresbach Township Clerk or Supervisor, where signs are posted indicating restricted parking. The permit must be displayed in a highly visible location inside the windshield or window of the parked motor vehicle.

<u>Section 2 – Handicap parking.</u> One Handicap parking spot is available at the Dresbach Boat Landing following MN Council on Disability requirements. Dresbach Board of Supervisors authorizes additional handicap vehicles to park at the Boat Landing without a permit as long as it has the proper Handicap credentials. Any vehicle not showing Handicap credentials and failing to display a permit will be sited as violating this ordinance.

<u>Section 3 – Park Parking</u>. Public parking spots at the Park are for Park & Beach use only. No overnight parking allowed at any time.

<u>Section 4 – Issuance of permits.</u> The Dresbach Township Clerk or Supervisor shall issue one (1) parking permit for the period of January 1 through December 31 of each calendar year to each resident of Dresbach Township who properly applied for the permit. Parking permits shall only be placed in motor vehicles owned by residents of Dresbach Township. The Dresbach Township Board of Supervisors shall prepare forms necessary for the application of said permit.

<u>Section 5 – Penalty.</u> Any person violating any provision of the Ordinance is guilty of a misdemeanor and upon conviction shall be punished by penalty established in State statute for a misdemeanor, as may be amended from time to time.

<u>Section 6 – Effective Date.</u> This Ordinance shall take effect from and after its passage and publication according to law.
